The Faculty of Medical Sciences in Kragujevac hereby announces a call for applications for the third enrollment period in the 2026/2027 academic year for the Integrated Academic Studies of Pharmacy study program taught in English.

A total of 26 self-financing students may enroll in the first year.

The tuition fee for self-financing students is RSD 320,000.00 for citizens of the Republic of Serbia and EUR 3,000.00 for foreign citizens. Payments should be made in accordance with the payment instructions.

Candidates who have completed the appropriate secondary education and hold a medical certificate may apply under this call.

Appropriate secondary education means completion of a grammar school, a secondary medical or veterinary school, or a vocational secondary school with an appropriate educational profile.

Candidates applying for enrollment in the first year take entrance examinations in Mathematics and Chemistry and attend an interview.

The Chemistry test contains 20 questions, each worth one point. The Mathematics test contains 10 questions, each worth two points. The interview is worth a maximum of 20 points.

Books for entrance examination preparation are available on the Faculty's website.

Candidates who are citizens of the Republic of Serbia must submit the following documents when applying:

- completed application form (available on the Faculty's website);
- original certificates for the first, second, third, and fourth grades of secondary school (for inspection);
- photocopies of the certificates listed above;
- original diploma (for inspection);
- photocopy of the diploma;
- birth certificate;
- medical certificate (issued by the competent healthcare institution);
- proof of payment of the entrance examination fee in the amount of RSD 14,000.00;
- proof of English language proficiency at a minimum of B2 level, or proof of previous completion of any level of education in English (diploma).

Note: Photocopies of documents presented for inspection do not need to be certified.

After submitting the documents, the candidate will receive an identification card bearing their application number.



Candidates who are foreign citizens must submit the following documents when applying:

- completed application form (available on the Faculty's website);
- proof that the original documents have been submitted for recognition to the National Agency for Academic Recognition, 51 Majke Jevrosime Street, Belgrade; contact email: agencija@azk.gov.rs; further information is available at http://azk.gov.rs/Biblioteka/Brosure/ENIC_NARIC_brochure%20ENG.pdf;
- scanned copy of the passport;
- scanned copies of the original documents confirming completion of the appropriate secondary education, translated into Serbian by a certified court translator;
- medical certificate (issued by the competent healthcare institution);
- proof of English language proficiency at a minimum of B2 level, or proof of previous completion of any level of education in English (diploma);
- proof of payment of the entrance examination fee in the amount of EUR 100.00, in accordance with the payment instructions.

After submitting the documents, the candidate will receive an identification card bearing their application number.

ENTRANCE EXAMINATION

The entrance examinations in Chemistry and Mathematics will be conducted online on September 16, 2026, from 13:00 to 15:00 Central European Time.

The interview will be conducted online on September 16, 2026, from 16:00 to 17:00 Central European Time.

Instructions for taking the entrance examination and examples of permitted and prohibited calculator types are available at medf.kg.ac.rs/informacije/upis/index.php#UpustvoPrijemni.

RANKING OF CANDIDATES

A candidate who, as a third- or fourth-year secondary school student, won one of the first three places in a national competition organized by the Ministry of Education or in an international competition in Biology, Chemistry, or Mathematics is exempt from taking the entrance examination in the relevant subject. The candidate will be awarded the maximum number of points for that subject.

This exemption does not apply to awards won at the national competition for scientific and artistic talents.

Candidates are ranked based on the sum of their average secondary school grades multiplied by two (maximum 40 points) and their entrance examination score (maximum 60 points).

The maximum total score a candidate may achieve is 100 points.

A candidate on the final ranking list who has achieved a total of at least 30 points may enroll in the study program.

The preliminary consolidated ranking list of candidates will be published on the Faculty's notice board and website.

A candidate may file a complaint with the Enrollment Commission regarding the regularity of the entrance examination or their position on the ranking list within 24 hours of the publication of the ranking list.

Upon the Commission's proposal, the Dean will decide on the complaint within 24 hours of receiving it.

The final ranking list of candidates, on the basis of which enrollment will be conducted, will be published on the notice boards and websites of the Faculty and the University.



ENROLLMENT OF CANDIDATES

Enrollment of candidates in the first year of the Integrated Academic Studies of Pharmacy study program taught in English will be conducted according to a schedule published on the Faculty of Medical Sciences website.

A candidate who does not enroll by the prescribed deadline will be considered to have withdrawn from enrollment.

Each candidate must submit the following documents:

- original certificate confirming completion of secondary school;
- diploma confirming completion of the final examination (matura), applicable only to citizens of the Republic of Serbia;
- original documents confirming completion of education and their certified translations, as well as the decision on their recognition issued by the National Agency for Academic Recognition (for foreign candidates); these documents may be submitted before the beginning of the academic year;
- two identical photographs measuring 3.5×4.5 cm;
- proof of payment of the first tuition fee installment: RSD 160,000.00 for citizens of the Republic of Serbia or EUR 1,500.00 for foreign citizens, in accordance with the payment instructions;
- certificate of residence (issued by the Ministry of the Interior, Department for Foreigners, Savska 35, Belgrade);
- proof of health insurance, applicable only to foreign candidates (issued by the Department of Foreign Insurance, Nemanjina 30, Belgrade, or by any private insurance company).

Upon enrollment, students enter into a study agreement with the Faculty.
